FOOD TO-GO BOXES: RECYCLABLE OR NOT?

Ordering delivery or to-go food more? You're probably wondering if you can recycle those plastic to-go boxes. Clamshell boxes are made with a type of plastic that melts at a different

temperature than other plastics in the recycling process, so they must be separated. In addition, markets for these materials are not currently available so we can't take them for recycling and the boxes should be placed in the trash. In fact, plastic clamshell boxes are the number one item on our "Recycling's Dirty Dozen" list! To read about 11 other items that seem recyclable but aren't, visit Sunnyvale.ca.gov and search Dirty Dozen.

If you're dismayed by this news, there are other things you can do to reduce plastic waste. When ordering takeout or delivery, specify that you don't want disposable utensils, sauce packets or even the bag the food is delivered in. If you do end up with plastic bags, use them as trash can liners (or doggie bag, if you have a dog!). Besides that, a great way to avoid waste is preparing meals at home. This saves money, helps you eat healthier and avoids extra packaging that ends up in the trash.

Santa Clara County **PUBLIC** HEALTH ORDER OF THE HEALTH OFFICER OF THE COUNTY OF SANTA CLARA DATE OF ORDER: 7/13/2020:

At 12:00 p.m. on July 13th, Governor Newsom announced that a number of indoor activities and industries will be closed statewide, and additional indoor activities and industries will be closed in counties that appear on the State's "monitoring list" for three days or longer. According to the State's website (covid19.ca.gov):

Effective immediately, California closes some indoor business operations statewide and additional indoor operations in counties on Monitoring List for 3 consecutive days. Statewide indoor closures include restaurants, bars and breweries, wineries and tasting rooms, movie theaters, family entertainment centers, zoos and museums, and cardrooms. County indoor closures include fitness centers, places of worship, indoor protests, offices for non-critical infrastructure sectors, personal care services, hair salons and barbershops, and malls. County closures apply to counties that have been on the County Monitoring List for 3 consecutive days.

The statewide closures are effective immediately as of Monday, July 13th. The State informed the County on July 13th that businesses and individuals in Santa Clara County will be required to comply with the list of County closures starting at 12:01 a.m. on Wednesday, July 15th. Closed statewide effective July 13th:

Restaurants Wineries and tasting rooms Movie theaters Cardrooms Family entertainment centers Zoos and museums Bars, breweries, and pubs (indoor and outdoor)

Closed in Santa Clara County effective July 15th:

Worship services Protests Gyms and fitness centers Offices in non-essential sectors Personal care services, e.g., nail salons, body waxing, tattoo parlors Hair salons and barbershops Shopping malls

HIGHLIGHTS OF LAST MONTH'S SNAIL MEETING VIA ZOOM Guest Speaker: LaTricia T. Frederick, Inclusion and Organizational Effectiveness Expert. LaTricia presented a little bit about herself. She told us about her family past so we can anchor where we are today in terms of race relations in America. The riots that resulted from Rodney King's death caught the attention of the nation. Today, again, the riots following George Floyd's death are what catches the nation's attention. She talked about the concept of institutional racism and she led a conversation focusing on allyship and advocacy.

Active Transportation Plan Update: Richard Mehlinger: The final version of the Active Transportation Plan (ATP) will be reviewed by City Council on July 28, 2020. Send your comments no later than July 27th via email to <u>council@sunnyvale.ca.gov</u> and specifically mention the ATP in the subject line. **Diane Gleason:** A local bike advocacy group is currently talking to CC members re supporting the BPAC recommendations for the ATP. **Barry Boole:** Borregas crosswalk still direly needed. **Faisal Jawdat:** Intersection of Maude and Arbor is particularly dangerous. Corner needs to be "daylighted". **John Cordes:** Update on bike lanes on Maude. Once the bike lane signs are installed, there will be a 6-month evaluation period.
